**Re: Prostitution Laws in Canada**

Dear Minister MacKay,

Since 2008 The Canadian Council of Churches – representing 85% of Christians in Canada through its 25 member churches – has been hosting the Human Trafficking in Canada Working Group. Together we have been educating one another, reflecting on our values and faith commitments, and advocating together to end human trafficking in Canada. Today I am writing to you regarding the development of new prostitution legislation in Canada.

The Chair of the Human Trafficking in Canada Working Group, Jennifer Lucking, and members of the working group have identified the links between prostitution and human trafficking and believe that legalizing or decriminalizing prostitution will further harm the majority of individuals in the sex trade who are exploited or desire to exit. We believe that we need to stop viewing prostitution as a vocation of choice and instead view it as an affront to gender equality and violence against women, children and marginalized populations. Today I would like to draw your attention to these modified recommendations drawn from the Evangelical Fellowship of Canada's report "Out of Business" (attached). Will you support these recommendations for Canada?

1. Parliament must be clear and unambiguous in the definition of prostitution as a form of violence, abuse and control of vulnerable children, women, and men.
2. Invest strongly in exit programs and support for prostituted persons along with restorative programs for perpetrators; with federal social funding commitment towards provincial governments for these purposes.
3. Criminalize the purchase and attempted purchase of sex.
4. Amend our laws to reflect the current non-criminal nature of individuals who are being prostituted. For example, removing the prohibition on communicating for the purposes of prostitution [section 213(c) of the *Criminal Code*] or restricting its application to the intended purchaser.
5. Maintain prohibitions against profiting from sexual exploitation; i.e. pimping.
6. Support strict crime diversion programs upon sentencing such as John's schools.
7. Engage the provincial governments, territorial governments, municipal governments, nongovernmental organizations and other public and private partners in the development of a comprehensive national plan or strategy with the objective of ending prostitution. This can happen when demand for prostitution is reduced, which also means addressing poverty and inequality. Incarceration will likely only postpone the issue.
8. Initiate a public awareness campaign to accompany such a change in the law, educating the public that paying for sex is both illegal and unacceptable; that it is violence against the victim and contrary to equality between the sexes. These need to include education on violence against women as well as violence against children as boys and young men are also victimized.

I look forward to receiving your response to these modified recommendations drawn from one of the organizations participating in the Human Trafficking in Canada Working Group, The Evangelical Fellowship of Canada. Members of the Human Trafficking in Canada Working Group, including representatives from the 25 member denominations of The Canadian Council of Churches, would also be pleased to meet with you and engage with you and your policy advisors on this topic.

Please be assured of our continued prayers for you and for the Government of Canada as you carry out your responsibilities.
